

Rental Agreement Terms and Conditions

By signing this contract, I agree to rent from Just Tables and Chairs Corp the equipment listed for the prices and rental period stated on the invoice, subject to the following conditions:

- 1. Equipment Care and Return: I agree to take care of the equipment and return it in the same condition as received.
- 2. Loss, Damage, and Replacement: I will be liable for the full replacement or repair value of any lost, destroyed, or damaged equipment.
- 3. Equipment Safety and Disrepair: I will promptly notify Just Tables and Chairs Corp if the equipment becomes unsafe or is in a state of disrepair. I will take necessary precautions to prevent injury until the equipment is returned.
- 4. Weather and "Acts of God": No refunds or changes due to weather or "Acts of God".
- 5. Rental Extensions: Any rental extension requires prior approval from Just Tables and Chairs Corp. Additional fees may apply.
- 6. Subleasing: Subleasing the rented equipment is prohibited.
- 7. Indemnification: I will hold Just Tables and Chairs Corp harmless for any damage or injury resulting from proper use of the equipment. I am responsible for all charges associated with the contract.
- 8. Refunds and Cancellations: No refunds on rentals once equipment leaves the warehouse. Deposits are nonrefundable.
- 9. Payment Terms: A 40% non-refundable deposit is required to book the order. The balance is due upon delivery or pickup.

Equipment Pickup Agreement Terms and Conditions

By signing this contract, I agree to pick up the equipment from Just Tables and Chairs Corp's warehouse for the rental period specified on the contract, subject to the following conditions:

- 1. Pickup and Inspection: I will inspect the equipment upon pickup and notify Just Tables and Chairs Corp of any concerns before leaving the premises.
- 2. Security Deposit: I agree to provide a security deposit of \$100 in cash upon pickup. The security deposit will be returned to me at drop off, provided there are no damages or outstanding charges.
- 3. Liability during Transportation: I assume full responsibility for any damages, accidents, or incidents that may occur during the transportation of the equipment.
- 4. Equipment Return in Same Condition: I will return the equipment to Just Tables and Chairs Corp's warehouse in the same condition as it was at the time of pickup, accounting for normal wear and tear. Any damages or outstanding charges will be deducted from the security deposit.
- 5. Safety, Misuse, and Liability: I will use the equipment safely and for its intended purpose. I understand that any damages, injuries, or liabilities resulting from improper or unsafe use shall be my responsibility, and I will hold Just Tables and Chairs Corp harmless.
